

PUBLIC SOCIAL DIAGNOSTICS REPORT

Throughout the life of each project (exploration, construction, operation and closure) we apply a community human rights due diligence process that has two components: the participatory social diagnostics and community outreach plans, and the Community Care Service.

The participatory social diagnosis helps the company to identify concerns, needs and desires of the community through focus groups, workshops, semi-structured interviews and surveys of various internal groups (adults, youth and children).

Likewise, risks and opportunities are identified in order to design actions to mitigate potential negative impacts and optimize the positives. These inputs are the basis for designing community outreach plans for each site with programs and projects that generate shared value.

As established in the Social Diagnosis procedure, these are performed at the beginning of each project and then updated every two years in all our business units in Mexico and Peru. However, it is important to note that due to the COVID-19 pandemic, there was an exception from 2020 to 2022 due to restrictions implemented worldwide.

Taking this into consideration, the social diagnosis for every site (14 productive assets, 6 projects and 2 inactive operations) is current or in the process of being updated in time as shown in the tables and maps below.
